**ORDER/SUMMON**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Ms. Bengia Mama for non-furnishing of 20(twenty) point information by the PIO, o/o the (BDO), Puchigeko, Kamle District (A.P) as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 24.03.2025.

Having failed to receive the requested information from the PIO and also positive response from the FAA, under section 19(1) of the RTI Act, the Appellant preferred this Second Appeal before this Commission under Section 19(3) of the RTI Act, 2005 vide memo dated 13/06/25.

This appeal was, accordingly, heard on 13.03.2026 wherein the appellant, Ms. Bengia Mama was present in person while the PIO, Ms. Api Nungnu appeared through VC.

This Commission, upon hearing the PIO and rejecting her submission that the appellant be directed to deposit the cost of documents and the postal charges in terms of the provisions of section-7(6) of the RTI Act, directed the PIO to furnish the requested documents to the appellant free of cost within 2(two) weeks from the date of receipt of the order dt.13.03.2025. The appellant, vide letter dt.06.04.26 (as reproduced hereunder) has complained that the PIO did not furnish the information despite this Commission's direction.

"Sir,

*With due respect and humble submission, I would like to solicit your good office that, on 13th day of March 2026 the matter had been fixed for hearing in your court with the PIO cum BDO, CD-Block Puchigeko, Kamle Dist. A.P. As per judgment dated 13th March, 2026, the PIO had been directed to submit or furnish the documents within two weeks from the date of the judgment. And the appellant had also directed to inform this court within one week. As I am informing that since the date of judgment to till date, the concerned PIO had fails to furnish the documents and fails to comply the court direction.*

*Therefore, you are highly solicited to continue the hearing and requested to fix the next date of hearing as per the convenient of the court as soon as possible' I shall be highly obliged to you and your saltruistic gesticulation.*

In view of the complaint from the appellant as above, the PIO is directed to furnish the requested information to the appellant in right earnest and report compliance thereof to this Commission on 13.05.2026, the next date of hearing so as not to constrain this Commission to invoke the penal provisions of RTI Act, 2005.
