The **1st hearing** was held on **17th November, 2025** related to the **APIC No-635/A/2025(Appeal)**. The PIO-cum-o/o Special Investigation Cell present in person but the appellant Shri John Tara Bakey found absent without any intimation to the Commission.

The PIO has stated that the sought information relating to Arunachal Pradesh Public Service Commission Paper Leak has been transferred to CBI on 08/03/2024. All the case record along with FIR copies of on-going report have been submitted to the CBI. CBI is a Central subject which covered under Central information Commission. So, he appellant is advised to seek information from the appropriate authority.

The appellant is also sought information in his application at Sl. No. 2 to 6 is as below:

2. List of persons named, arrested, interrogated or charge-sheet in connection with the APPSC paper leak case.
3. Status of each accused including whether departmental action was taken.
4. Internal notes or communication between SIC and State Government regarding investigation or prosecution.
5. A detailed list of all cases registered and investigated by the SIC from January 1, 2021 to the present stating for each.
 - a. FIR No. date and case file.
 - b. Nature of offence and IPC/PC Act sections invoked.
 - c. Name of accused/Officers involved.
 - d. Present status: pending/disposed.
 - e. For disposed cases: Date and mode of conclusion.
 - f. For pending cases: specific reasons for pendency (e.g.) investigation delay, court stay, etc.)
6. Summary of total number of cases settled/disposed (2021 to till date).
 - a. Total pending cases with classification of reasons for delay.
 - b. Any internal reviews, circulars or accountability memos related to delay s or investigations.

The PIO is directed to reply to the information if it can be provided or not. If, the information can be provided as per the provision of the RTI. The PIO is directed to furnish before the next date of hearing.

The Commission adjourned the hearing and fixed next date of hearing on 21/01/2026 at 2 PM.
