WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 1125/2023**, your personal appearance is required before the Commission on **3rd July, 2025 at 10:30 AM**. The 3rd Hearing held on **17th Apr'2025**, related to the **APIC No 1125/2023**. The Appellant Shri Sanghe Radhe, found absent during the hearing and PIO-cum Executive Engineer (**PHE &WS**) Koloriang Arunachal Pradesh,, also absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

During the last hearing the PIO stated before the Commission that he has brought all the information(s) as sought by the Appellant in his form 'A' application and wanted to handover all the information(s) to the Appellants before the Commission but Appellant was absent, so he could not hand over the information(s). However in today's hearing both the parties remained absent.

The Commission seriously viewed the absence of both the parties and hereby orders;

- (i) The PIO to provide all the information(s) to the Appellant on or before the next date of hearing as sought in his form 'A' application. **Failing which necessary action shall be initiated against the PIO as per the provisions of the RTI Act 2005, and to be present in the next date of hearing.**
- (ii) To issue **warning summon** to the Appellant to appear before the Commission in person or through online mode in the next date of hearing. **Failing which his appeal shall be decided ex-parte.**
- (iii) **Due to absence of both the parties, the Commission could not proceed the hearing of the appeal.**

The Commission ordered;

The next date of hearing be fixed on 3rd July 2025 at 10:30 AM (Morning).
