**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Kaya Parang Londa, Bank tinali, Near king cup Public School, Lowang Appartment, Itanagar Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-DFO, Govt. of A.P., o/o Divisional Forest Officer, Khellong Forest Division, West Kameng District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 09/05/2023 regarding CAMPA FUND UNDER CA, ACTIVITIES.

The 2<sup>nd</sup> hearing is held on 27<sup>th</sup> February, 2024 as scheduled. Shri Aduk Paron, the SPIO-cum-DFO, Govt. of A.P., o/o Divisional Forest Officer, Khellong Forest Division, West Kameng District, Arunachal Pradesh and the Appellant Shri Kaya Parang Londa are present. The PIO has submitted that in compliance with the directions of the commission made on 21<sup>st</sup> November, 2023 has provided the list of work undertaken under CAMPA for the financial 202-21 under Khellong forest division, but the post office has re-directed the letter stating that the addressee is not found. So, the PIO has handed over hard copy brought during the hearing. The appellant has chosen for the information at Sl.no. 30, i.e. Maintenance of habitat improvement through ANR plantation constructed under State CAMPA AOP 2015-16.

The PIO is directed to provide information as mentioned within fifteen days from the date of issue of this order to the appellant with intimation to the commission. To ascertain compliance next date of hearing is fixed.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal provision under section 20(1) of the RTI Act 2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant no more interested it he information.

**The next date of hearing is fixed on 9<sup>th</sup> April, 2024 (Tuesday) at 1030 hrs.**

**Therefore, the SPIO-cum-DFO, Govt. of A.P., o/o Divisional Forest Officer, Khellong Forest Division, West Kameng District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.**
