### **ORDER/SUMMON**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Losik for non-furnishing of 23(twenty three) point information regarding State Own Revenue (SoR) Schemes in the entire Kurung Kumey District during 2022-23, 2023-24 by the PIO, o/o the District Panchayat Development Officer, Koloriang, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 12.09.2024:

This appeal has been heard for the 3(three) times earlier on 02.07.2025, 03.09.2025 and 24.09.2025.

In the last hearing on 24.09.2025, the PIO Shri Nangram Pingkup, the DPDO along with Shri Chera Tapung , (PTA)-cum-District Nodal Officer (DNA) were present in person with the requested documents. The appellant Shri Bamang Losik was also present in person.

The documents brought in by the PIO were handed over to the appellant with direction to go through the same and report his satisfaction or otherwise therewith within 1 (one) week for consideration of the appeal by this Commission, if required.

The appellant, Shri Bamang Losik, vide letter dated 1<sup>st</sup> Oct. 2025, accordingly, intimated that he has received only partial information / documents from the PIO and pleaded for appropriate direction to the PIO to furnish the left out documents and also affidavit against those documents which are not available. In view of the complaint of the appellant as above, this Commission, vide order dt. 21.10.2025, directed the PIO to furnish the documents in complete and satisfactory form to the appellant. At the same time, it was also made clear that if the documents/information requested by the appellant were not held by the o/o PIO the PIO shall furnish a declaration to that effect in an affidavit as mandated by section-18(3)(c) of the RTI Act and under rule-5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005.

The PIO was thus directed to comply with the above direction within 2(two) weeks from the date of receipt of the order dt.21.10.2025 and report compliance thereof on 12.11.2025, the next date of hearing.

Today the appellant is present in person. But the PIO is represented by Shri Durga Bengia, Computer-cum-Account Assistant, o/o the DPO, Kurung Kumey Distt., Koloring with the remaining documents.

The documents/information brought in by the representative of the PIO have been handed over to the appellant who went through the same during the course of hearing. This Commission also perused the point-wise replies /information furnished by the PIO vide letter dt.10.11.2025 whereupon it was noticed that the PIO had furnished the replies to almost all the points but there are still same points, as given below, against which replies /information have not been furnished:
