ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 32 (thirty two) point information on C/o "Development of wayside Amenities at Tago Puṭu, Yazali, Keyi Panyor District" during the financial year of 2017-18 under NEC project by the PIO, o/o the Executive Engineer (RWD), Yazali Division, Keyi Panyor District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.05.2025.

This appeal was heard for 2(two) times on 12.12.2025 and 04.02.26.

On 12.12.29 wherein the appellant, Shri Tamchi Gungte and the representative of the PIO, Shri Bengia Chito with the requested documents/information were present

The documents brought in by the PIO's representative were handed over to the appellant who was directed to go through the same and report his satisfaction or otherwise therewith to this Commission within 1(one)week for further consideration of the appeal.

In compliance with this Commission's order dt.12.12.2025, the appellant, vide his letter dt.19.12.2025, has complained that the documents furnished by the PIO were incomplete.

In view of the complaint of appellant as above, the PIO was directed to furnish the left out documents/ information to the appellant and report the compliance therewith to this Commission in the next hearing on 4th February, 2026. It was, however, made clear that if the PIO does not hold any of the requested information / documents, he shall declare so by way of an affidavit as mandated under section-18(3)(c) of the RTI Act, 2005 and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005.

On 04.02.2026, appellant was present in person while the PIO was represented by Er. Rallo Bath, JE with the left out documents/information which were handed over to the appellant Shri Tamchi Gungte.

This Commission noticed that some of the documents/information requested by the appellant were not furnished as these were not traceable /available in the o/o the PIO. But since the law requires under section-7(8)(i) of the RTI Act that when an information is denied to the applicant, the reason thereof has to be communicated to the applicant to his satisfaction, the PIO was directed to make an endeavor to collect the documents/information which are still in the custody of the Tourism department and furnish the same to the appellant and also furnish affidavit against those which are not traceable as mandated by section-18(3)(c) and under rule-5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005.

The PIO was, hence, directed to comply with the above direction within 3 (three) weeks from the date of receipt of this order.

This Commission is, however, in receipt of following complaint dt.25.02.26 from the appellant:

“Respected Sir,

With due respect, I am writing this letter to inform you that, the PIO Has failed to furnish the remaining documents as per the Judgement passed in the last hearing of this case. The PIO has failed to obey the court order, as it shall be declared as Contempt of Court. Therefore, I request the Honorable Judge to pass a penal action against the PIO under relevant section of the RTI Act 2005 and provide me another date to hear the matter thoroughly of both the PIO and Appellant.
