ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of below mentioned information by the PIO, o/o the EE (RWD), Laaying Yangte Division, Kurung Kumey District Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.05.2025:

A. Particulars of the Information: Under Budget Estimate (BE) 2024-2025.

1. C/o 20 bedded Hostel Building including Kitchen & Dinning Hall with Warden Room and 4 Unit Type II Qtrs. (G+1) at GMS Koloriang.
2. C/o 20 bedded Hostel Building including Kitchen & Dinning Hall with Warden Room and 4 Unit Type II Qtrs. (G+1) at IGSS Nikja.
3. C/o 20 bedded Hostel Building including Kitchen & Dinning Hall with Warden Room and 4 Unit Type II Qtrs. (G+1) at GUPS Pachangriang.
4. C/o 20 bedded Hostel Building including Kitchen & Dinning Hall with Warden Room and 4 Unit Type - II Qtrs. (G+1) at GUPS Yarba.
5. Infrastructure Development of GSS Parsi Parlo (Kurung Kumey)

C. Period for which information asked for : 2024-2025

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the appellant, Shri Bamang Pacho had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer, (RWD), Govt. of A.P (Western Zone), Itanagar the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide Memo of Appeal dt. 25.06.2025 .

Records further reveal that the First Appellate Authority-cum-Chief Engineer, Central Zone-A, PWD, Itanagar conducted the hearing on 29th July, 2025, wherein the appellant, Shri Bamang Pacho and the respondent Er. N Bhat, EE-cum-PIO, Laaying Yangte were present and the FAA passed the following order :

"JUDGEMENT/ORDER

The 2nd Hearing related to RTI No.RWD/RTI-277/2025, regarding "Under BE 2024-25", held on 29/07/2025 at 1430 hrs in the office chamber of FAA-cum Chief Engineer (W/Z), RWD, Itanagar.

The Appellant shri, Bamang Pacho was present and the Respondent Er. N Bhat, EE-cum-PIO, RWD, Laaying Yangte Division. was also present.

The Appellant stated non furnishing of required documents from the concerned Division as per his RTI application in Form 'A' No. nil dated 14/05/2025

The Respondent stated that the documents are at Sub-Division and presently the AE is at Delhi regarding PMGSY-IV duty. As soon as the AE return from Delhi, the sought documents available will be provided to the appellant as per RTI Act' 2005.

The FAA after hearing the submissions made by both the parties and going through available records/documents hereby order.

(a) That the information sought by the Appellant to be provided by the PIO-cum-EE, RWD, Laaying-Yangte Division, as applicable under RTI ACT 2005, directly to the Appellant with a copy of intimation to the undersigned. In case of non-furnishing of documents, the reason to be mentioned thereof.

(b) In view of the above submissions and records, this appeal is fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed once for all.

(c) Liberty to Appellant for filing appeal for the instant case if not satisfied

However, the appellant failed yet again to obtain the information and therefore, he preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide Memo of appeal dt. 12.09.2025.

This appeal is, accordingly, listed today on 19th December, 2025 wherein the appellant, Shri Bamang Pacho is present in person but the PIO is absent without any intimation.

Hearing and decision:

Heard the appellant who pleaded for stringent action against the PIO for his failure to provide the requested information despite the direction of the FAA and for not attending the hearing.

This Commission perused the points on which the appellant has sought the information/documents and noticed that the requested documents are not covered by the exemption provisions of section 8 of the RTI Act, 2005.

The PIO is, therefore, directed to furnish the requested information and report the compliance thereof on 21.01.2026, the next date of hearing.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 21st January, 2026 (Wednesday) at 10:30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence.
