ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Ms. Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (RWD), Ziro Division, Lower Subansiri District (A.P) as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 24.03.2025.

- A) Particular of information:** Construction of approach road at Duku (SSB) Gate, Ziro-I in Lower Subansiri District (A.P)
- B) Details of information required:**
1. Furnish Sanction order/copy.
 2. Furnish Details Project Report (DPR).
 3. Furnish Work order.
 4. Furnish TS copy.
 5. Furnish Geo Tagging details in colouring photos. The Longitude and Latitude must have clear and visible.
 6. Furnish detail copies of Material Procurement of Challans
 7. Furnish Photograph of project before, during and after the completion of the project in coloring photo
 8. Furnish Payment Cheque leaf/ PFMS/DBT transaction receipt copy
 9. Furnish Letter of Credit (LOC)
 10. Furnish Notice Inviting Tender (NIT) details with NEWS paper cutting.
 11. Furnish the Name of bidder with detail supporting documents of the same.
 12. Furnish a copy of Approved drawing & assurance letter from the NIT.
 13. Furnish copies of the contractor licenses of the selected bidders, including the date of registration and any relevant updates or renewals.
 14. Furnish Completion Certificate.
 15. Furnish Utilization Certificate.
 16. Furnish details of monthly monitoring report from Directorate Office, SJETA with colouring photos during spot visit by the monitoring team from Director Office, SJETA, Itanagar.
 17. Furnish quality assurance certificate from the nearest IIT/NIT.

18. Furnish all the documents in proper paging with CTC in each page and please to furnish within 30 days from the date of receipt as per RTI act otherwise the appellant is not liable to pay any fees as per sub-section (6) of the Section (7), RTI Act, 2005.

C) Period for which information is sought for: 2023 to 2024.

Facts emerging from the appeal:

The records in the appeal reveal that the Appellant, Ms. Bengia Mama had filed application dated 24/03/25 before the PIO o/o the EE (RWD), Ziro Division, Lower Subansiri District, Arunachal Pradesh requesting for the aforementioned 16 (sixteen) point information regarding Construction of approach road at Duku SSB Gate, Ziro-I in Lower Subansiri District (A.P)

Having failed to receive the information(s) from the PIO, the appellant filed 1st appeal under Section 19(1) of the RTI Act, before the First Appellate Authority (FAA), the Director (SJETA), Banquet Hall , Itanagar, AP, vide Memo of Appeal dated 06/05/25. However, having failed again to receive the information(s), the Appellant preferred Second Appeal before this Commission under Section 19(3) of the RTI Act, 2005 vide Memo of Appeal dated 13/06/25.

This appeal is, accordingly, listed today on 11.03.2026.

The appellant, Ms. Bengia Mama is absent who informed vide her letter dt.06.03.2026 that due preoccupation in a family ritual/programme, she will not be able to attend the hearing. However, the APIO, Er. Shri Sachin Jerang, JE is present with the requested documents which shall be handed over to the appellant and direct her to intimate this Commission of shortcomings, if any, therein within 1(one) week from the date of the receipt of this order.

This Commission, on perusal of the replies/information so brought in by the APIO, noticed that the replies against number of queries have been stated as 'Not Applicable' which is not acceptable under the RTI Act, 2005.

In this regard this Commission deems it appropriate to bring the attention of the PIO to the requirement of law under section -7(8)(i) of the RTI Act that when an information is denied to the applicant, the reason thereof has to be communicated to the applicant to his satisfaction. And as mandated by section-18(3)(c) of the RTI Act, 2005 and under rule- 5(vi) of the AP Information Commission (Appeal Procedure) Rules, 2005, the submission/replies of the PIO have to be furnished by way of an affidavit. The PIO is, therefore, directed to furnish the reasons for denial of information/replies to those queries to the appellant, with intimation to this Commission and report the compliance thereof to this Commission on 24.04.2026. The appellant is also directed to collect the documents/information from this Commission within 1(one) week from the date of receipt of this order.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
