SUMMON.

The 1st hearing held on **23rd July'2026** related to the **APIC No-110/A/2026**. The Appellant Shri Tamchi Gungte, absent despite notice for today's hearing sent to him on **29/04/2026**, and without reporting the reason for his absence to the Commission.

The PIO-Cum- Executive Engineer (PHE & WSD) Dirang Division West Kameng District, Govt. of Arunachal Pradesh, represented by Shri Taming Tok UDC PHE Dirang Division with a letter of authorization dated **21/07/2026**.

Heard the representative of the PIO.

The representative of the PIO stated that the PIO's office has not received the form 'A' of the Appellant and was only served a copy of the same in the court of the First Appellate Authority (FAA), while hearing the 1st appeal.

The Appellant has applied for multiple information for all the works undertaken at the office of the PIO since **2016-2026**, spanning to 10(ten) years and to provide information for ten(10) years for all the works under the office of the PIO, cannot be provided because, it will disproportionately divert the resources of the PIO's office..

Therefore, this appeal may be dismissed by the Honourable Court of the Commission.

After hearing the representative of the PIO and seriously viewing the absence of the Appellant the Commission hereby pass the below order;

- i) Issue **summons** to the Appellant to be present in the next date of hearing without fail, **failing which this appeal will be heard and determined ex-parte.**
- ii) The PIO to be present in the next date of hearing without fail, failing which the Commission will initiate necessary action as provided under RTI Act 2005 against the PIO.

The Commission hereby orders;

The next date of hearing be fixed on 1st October 2026 at 10:30 AM (Morning).
