Dear Sir/Madam,

The Hon'ble Supreme Court in Writ Petition (C) No. 360 of 2021, Shri Kishan Chand Jain *versus* Union of India & Ors, has, vide its order dated 09.10.2023 (copy enclosed) directed for enhancing access to Information Commissions being integral to securing the Right to Information, and accordingly directed that all SICs across the country must provide hybrid modes of hearing to all litigants for the hearing of complaints as well as appeals. The operating Paras of the order, inter alia, include the following:

Para 23 of the order: "......We direct that all SICs across the country must provide hybrid modes of hearing to all litigants for the hearing of complaints as well as appeals. All SICs must provide an option for availing of a hybrid mode of hearing which shall be at the discretion of the applicant, or as the case may be, the appellant. The links for availing of the option must be stipulated in the daily cause list of the Information Commissions across the country. This shall be operationalized no later than by 31 December 2023."

Para 24 of the order: "...... We direct that all SICs must ensure that e-filing of ii. complaints and appeals is provided in a streamlined manner to every litigant. Steps should also be taken having regard to the provisions of Section 26 of the RTI Act to ensure that service is effected on the Public Information Officers through the electronic mode. This shall also be implemented by 31 December, 2023."

Para 25 of the order: "......All Central and State Ministries shall take steps within a period of one month from the date of this order to compile the email addresses of the Central and State Public Information Officers which shall be furnished to the CIC and to all the SICs, as the case may be."

Para 26 of the order: ".....we direct that the Secretary, Department of Personnel and Training shall convene a meeting of all the Central and State Information Commissioners within a period of one month from the date of this order. Comprehensive modalities for the implementation of the above directions shall be

Para 27 of the order: "......All the State Governments shall cooperate in the implementation of the order. The State Governments shall, where funds are required, ensure provision of necessary tunds to all the SICs for setting up the infrastructure for conducting virtual hearings. The CIC and SICs would be at liberty to avail of the facilities which have been provided by the NIC for setting up the websites on the S3 WAS Platform which provides for ease of access in the electronic mode."

- 2. The Hon'ble Apex Court has directed to **implement the above directions (i) and (ii) above by 31st December, 2023** to ensure ease of access to citizens in pursuing their hearings, complaints and appeals under RTI Act.
- 3. Further, the direction at (iii) above is required to be implemented by the State Governments / SICs in a time bound manner. A copy of the compliance report may be sent to DoPT by email to usir-dopt@nic.in latest by 15th November, 2023.

Dear Chief Secretary,

As you are aware, Hon'ble Apex Court vide order dated 09.10.2023 in the matter of W.P.(C) No. 360/202, Shri Kishan Chand Jain vs. Uol & Ors., has directed all State Information Commissions (SICs) to provide hybrid modes of hearing to all litigants and to enable e-filing of complaints/ appeals. The Hon'ble Apex Court has directed to implement the above directions by 31st December, 2023. In this connection, D.O. letter from JS, DOPT of even no. dated 07.11.2023 had been issued to all States as well as SICs (copy attached for ready reference).

- 2. Meeting in this regard was held on 17.11.2023 with all the State CICs/SICs, senior officers of MEITY, NIC and other Departments and senior functionaries of State Governments. During the meeting, the representatives of all the SICs and States, where such arrangements were not fully in place (List at **Annexure**), had agreed to put in place the required mechanism by the stipulated deadline.
- 3. As the matter is of utmost importance, I urge you to kindly look into the matter personally and ensure compliance with the directions of the Hon'ble Supreme Court by the stipulated deadline.
