ORDER

- 1). The 2nd hearing was held on 14th July' 2026 (Tuesday) at 1100 hrs. The PIO-cum-EE (WRD), Bordumsa Division, Changlang District, Arunachal Pradesh was represented by Er. J. Sangno, APIO, through Video Conferencing. The Appellant Shri Ratan Chetia also attended the hearing through Video Conferencing.
- 2). The PIO submitted that he had furnished the remaining information to the Appellant.
- 3). However, the Appellant informed the Commission that as per the direction of the Court he had submitted a list of information. The Appellant agreed that on 13th July' 2026, he received the documents from the PIO, however, after going through in details he found them incomplete. He further alleged that the information which was provided earlier was refurnished, implying that the PIO was not serious about furnishing the information.
- 4). The Commission directed the PIO to provide the balance of information as per the list submitted by the Appellant. Incase the information was not available the PIO was advised to give justifiable reasons or submit it's non-availability through an "affidavit". The PIO was granted 15 days time to furnish the balance information to the Appellant from the date of issue of this order.
- 5). On verbal request of the Appellant, the Commission granted permission to the Appellant to visit the construction site of the MIC project area.
- 6). The Court further directed that the next date of hearing would be decided based on the input of the Appellant within 15 days of receipt of balance of information.
