ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Arjun Jebisow, Bhalukpong, West Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PHE & WS), Govt. of A.P., Bomdila Division, West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/10/2025 regarding Maintenance of mainline 200mm Dia pipeline and 150mm Dia pipe at Bhalukpong, BE provision LFY 2024-25.
- 2). The 1st hearing was held on 5th May' 2026. The PIO-cum-EE (PHE & WS), Govt. of A.P., Bomdila Division, West Kameng District, Arunachal Pradesh was represented by Er. Kipa Raju, AE (PHE & WS), Bomdila Division. The Appellant Shri Arjun Jebisow appeared before the Court through video conferencing.
- 3). The Appellant informed the Commission that the PIO had furnished incomplete information. Information for Sl.no. 4, 5, 6, 7 & 11 of the Form A dated 13/10/2025 had not been furnished. He further informed that an amount of Rs. 150 lakhs had been sanctioned to implement above work and according to the District Based Entrepreneurship, NIT had to be done but the procedure had not been followed to award the work.
- 4). The representative of the PIO submitted that during monsoon season, infrastructure of water supply got damaged without warning, affecting the water supply to the people. So the work had to be implemented under SOS without waiting for funds. Since, the work was implemented on work order basis and the expenditure amount paid as arrears to the firm after approval from the government, the tender was not done.
- 5). The Commission, directed the PIO to furnish information for sl.no. 4, 5, 6, 7 & 11 of the Form A dated 13/10/2025 as sought by the Appellant. In case information were not available the PIO should give justifiable reasons in writing to the Appellant under intimation to the Commission. The PIO was directed to furnish information within fifteen days from the date of issue of this order.

6). The Commission also asked the Appellant to intimate his satisfaction or dissatisfaction after receipt of information.

7). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant failed to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.
