Information sought:

The appellant filed an RTI application dated 21.01.2025 seeking following information regarding 'specified name of scheme list and name of Agency with sanctioned amount under the funding head of SIDF from 2019-2024'.

Details of information required:

1. Give the Technical Sanction (TS) Sanctioned order/Work Order copy/first & final bill copy/LOC copy with details of payment like Xerox copy of Cheque leaf/demand draft/banker cheque/Pay In slip for NEFT/RTGS which paid against name of above-mentioned work and Name of Agency list.
2. Give the Name of Contractor/Agency with their bank account number.
3. Give Colouring Photocopy of Geo-tag Report of work wise.
4. Give the Money Received List of Contractor/firm bill Payment with their name & contact number of person who received the payment.
5. Give the Xerox copy of Trading License of firm/Agency with contact number of Proprietor/Agreement copy of work which carried out by department and contractor.
6. Give the details of billing Sheets/scheme Sheets copy of work wise.
7. Give the details of MB records/Cashbook Statement.
8. Give the Certified Colouring Photocopy of all the work Sites by Concern Officer.
9. Give the NOC copy of ZPC/ZPM/GPC/Gaon buras/Gaon buris of concern village/block.
10. Give Name of Officers & Officials who carried out the Works.

11. Give details of Enlistment of contractor as per work department Rules Act 2008.
12. Give details of proprietor of firm/Registration of certificate.
13. Give the Money deposited Challan of Govt. account against GST/Royalty by department/firm in work wise.

ALL the document must be provided in CTC by Concern Pio.
Period from which information asked for: - 2019-2024.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the PIO, observes that the FAA has heard the appeal and disposed of the appeal case on 06.05.2025 stating that the information sought by the appellant is for multiple years and multiple number of schemes which is not possible.
