Information sought:

The appellant has filed an RTI application dated 27.09.2025 seeking following information with respect to C/o "Total list of works/ projects sponsored by state fund/ Central fund or both (such as SIDF/BE/RE/RIDF/SADA/ADA/MLALAD/MPLAD/SPA/Article 275(1)/PMJKV/ erstwhile MsDP/ CRIF/PMDeVine/NEC/NESIDS/Non-BADP/ SASCI/VVP,PMGSY/ maintenance work etc.), executed under the concern division" from the financial year 2016 -17 to 2025-26.

Particulars of sought information are given below: -

- 1.Copy of Total list of works/projects under various scheme head mentioned above (state/central scheme or both as mentioned above) executed under the division, along with the details of cost of each project for each financial year from 2016-17 to 2025-26.
- 2.Copy of total amount of LOCs and Fund allocations received (in which ever form they used) to the division for each project in respect of serial no.1.
- 3.Copy of total amount of funds received in the division in respect of Serial no.1, undertaken and executed by the division from each financial year from 2016-17 to 2025-26.

4. Reply statement from the division that the complete payment has been made as per LOCs/ fund allocation to the contractor, after certain deduction mandate by the Govt.
5. Copy of total amount deducted as, Labour cess of 1% from total cost of each work/project under Building and Other Construction Worker Act 1996, in respect serial no. 1.
6. Copy of Labour Cess deposited (such as Challan copy, Cheque counterfoil, Demand draft etc. whichever method is used) to the competent authority (APB&OCWWB) by the division for each financial year from 2016-17 to 2025-26.
7. Details of Officers (Name & Designation then & now) who is/are responsible for deducting Labour cess from the all projects/work executed under the division for each financial year from 2016-17 to 2025-26.
8. Details of Officers (Name & Designation then and now) who is/are responsible for depositing the Labour cess for the all projects/work executed under the division to the competent authority for each financial year form 2016-17 to 2025-26 as per Building and Other Construction Act 1996.
9. Details of third-party officer/Audit Officer for verifying whether the proper/right amount of Labour Cess was deposited by the competent authority in respect of all the projects/works, to the concern authority (APB&OCWWB) for each financial year from 2016-17 to 2025-26.
10. Copy of total amount deducted as, Contingency charges deducted (i.e. project cost up to 3 crores is 1.5% & the project cost above 3 crore is 1%) in details, from each project/work in respect of all the works/projects executed under the division for each financial year from 2016-17 to 2025-26.
11. Copy of expenditure Details (along with supporting documents of expenditure) done by the concern Officers (Name & designation then & now) of Contingency charges in respect of serial no. 1.
12. Furnish all the above documents with CTC & proper manner (i.e. in serial wise with properly Index and proper paging of each financial year).

The following were present.

Appellant : Present. He states that the PIO has not furnished any information to him in spite of order issued by the FAA- the Chief Engineer, RWD (EZ), Itanagar. He further states that he has visited the office of the PIO at Namsai twice but he could not obtain the requisite information documents.

Respondent PIO : Absent.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the appellant, observes that the FAA has served a hearing summon notice dated 13.11.2025 to the PIO and the appellant for 18.11.2025. The appellant has produced a copy of judgement order dated 22.12.2025 of the FAA – Chief Engineer RWD, EZ, Itanagar wherein the PIO was directed to furnish the information within first week of December' 2025. There is no record of any information furnished by the PIO.

The PIO was absent in today's hearing without intimation of any reason thereof which is violation of statutory duty of a public authority. The PIO is directed to furnish the information as sought to the appellant within two weeks from the date of issue of this order under intimation to this commission. The appellant shall serve a copy of this order to the PIO and obtain acknowledgement. The appellant shall file a status report to this commission within one week upon receipt of information from PIO.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. The PIO is directed to attend the next hearing personally or through his counsel. In case of failure an appropriate compensation shall be awarded to the appellant. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.

Order pronounced in the Open Court of this Commission today this 20th day of July' 2026. Each copy of the Judgement / Order be furnished to the parties.

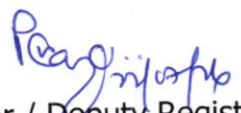
