ORDER

The 1st hearing held on 14th July 2026, related to the **APIC No-367/2025(Appeal)**. The Appellant Ms Bengia Mama, present during the hearing and PIO-cum District Medical Officer Kra-Daadi District, Govt. of Arunachal Pradesh, is present during the hearing through online mode.

Heard the Appellant.

The Appellant stated before the Commission that PIO has not provided her the information till now.

Heard the PIO.

The PIO stated that all the information have been sent to the Appellant in soft copy through whatsapp messaging app on 16/6 /2026. The PIO further stated that the hard copy of the information as applied by the Appellant are ready at his office to be furnished to the Appellant.

After hearing both the parties the Commission hereby order;

- i) The Appellant to collect the information from the office fo the PIO-cum District Medical Officer (DMO), Kra-Daadi District, Govt of Arunachal Pradesh.
- ii) The Appellant to report back to the Commission whether the information as received from the PIO are complete or not.
- iii) The Appellant to be present in the next date of hearing without fail, **failing this Commission will presume that the information have been received from the PIO completely and therefore, this Commission will hear and determine this appeal ex-parte by way of disposing of this appeal.**
- iv) The PIO to be present in person or through online mode before the Commission in the next date of hearing without fail, **Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act 2005.**
- v) Notice need not be served to both the parties as both the parties are present during hearing.

The Commission hereby orders;

The next date of hearing be fixed on 24th Sept 2026 at 10:30 AM.
