ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengai Mama, Dariya Hill Colony, near Donyi Polo Road, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/03/2025 regarding construction of Suspension Bridge over Kojen river in between Rigia to Duchok in Upper Subansiri District, Arunachal Pradesh.

2). The 4th hearing was held on 25th August 2026 (Tuesday) at 1100 hrs. Er. Taluk Rai, PIO-Cum-EE (RWD), Daporijo Division, Upper Subansiri District, Arunachal Pradesh appeared before the court through online video conference and the representative of the PIO, Er. Taku Raji, AE-cum-APIO and the Appellant Ms Bengia Mama were present in the court during the hearing.

3). The PIO submitted that he was in Delhi owing to health issues and that, he would be represented by the APIO in the court. He further informed that he had tried to meet the Chief Information Commissioner in person to explain the reasons for his absence in the previous hearing but could not meet as the hon'ble Chief Information Commissioner was out of station. He apologized for the absence which was totally unintentional.

4). The APIO submitted a copy of challan as proof of payment against penalty imposed under section 20(1) of the RTI Act. The APIO also informed the Commission that the information had been dispatched at Appellant's address through postal service on 3rd August 2026.

5). However, the Appellant informed that she had not received any letter from the office of the RWD, Daporijo Division till date.

6). The Commission directed the PIO and the APIO to convert hard copy information into soft copy and furnish the information electronically in the mail ID of the Appellant or share in her Whatsapp within fifteen days from the date of issue of this order.

7). The Appellant was directed to intimate her satisfaction or dissatisfaction to the Commission after receipt of the information. Next course of action would be taken based on the feedback from the Appellant. However, if the Appellant failed to intimate within twenty days from the date of issue of the order the case would be disposed of.
