ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Nabam Tadap, Zoo Tinali Road, Po. DNG College, Ps Chimpu, Itanagar, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer (PIO), O/o the Directorate, Biological Zoological Park, Itanagar, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 22/10/2025 regarding annually fund allocation from Govt. of Arunachal Pradesh/ India for feeding animals and birds and infrastructure development of Biological / Zoological Park, Itanagar.

2). **The 3rd hearing was held on 1st September 2026.** Shri R. Flago, PIO-cum-Director, O/o the Directorate, Biological Zoological Park, Itanagar, Arunachal Pradesh, and the Appellant, Shri Nabam Tadap were present.

3). Shri R. Flago, PIO-cum- Director, O/o the Directorate, Biological Zoological Park, Itanagar, informed the Commission that he had joined recently. He also informed that the previous PIO, Shri Subu Hania due to medical issues, could not attend the earlier court hearings and that now he stands to the Headquarter office.

4). The present PIO also submitted that he had no idea about the case. However, he assured to furnish all the available information as sought by the Appellant.

5). The Commission directed the present PIO Shri R. Flago to intimate the previous PIO, Shri Subu Hania to tender a written apology for violation of the provisions of the RTI Act, failing which penalty of Rs. 25, 000/- (Rupees twenty five thousand only) would be imposed on him under section 20(1) of the RTI Act.

6). The Commission, also directed the PIO to furnish all the available information to the Appellant within fifteen days from the date of issue of this order. In case, any information not available, the PIO should give in writing the reasons for non availability to the Appellant under intimation to the Commission.

7). The Appellant was also directed to receive information from the PIO and convey his satisfaction or dissatisfaction to the Commission within fifteen days from the date of receipt of information from the PIO, failing which the case would be disposed of.
