ORDER

The 2nd hearing held on 4th August 2026, related to the **APIC No-159/A/2026**. The Appellant Miss Bengia Mama is present during the hearing through online mode before the Commission.

The PIO-cum-BDO, CD-Block, Kaying Payum, Siang District, Govt. of Arunachal Pradesh is present through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that the PIO had asked her to deposit the fees for the information but as the online payment portal of the treasury department is not functional for the Kaying Payum CD, Block and therefore, the Appellant is not able to pay the requisite fees for the information(s) till now and the payment of the fees cannot be done by offline mode as the banks don't accept offline mode of payments these days.

Heard the PIO;

The PIO stated that the information as sought by the Appellant are ready in the office and the available information may be collected by the Appellant on any working day from the office of the PIO.

After hearing both the parties the Commission hereby orders;

- i) The Appellant to purchase IPO of the value for the information fees as prescribed by the PIO for the value of Rs 100/- (Rupees one Hundred) only and submit it to the office of the PIO in person and collect the information.
- ii) The PIO to furnish the information to the Appellant on receipt of the fees in the form of IPO whenever the Appellant presents herself at the office of the PIO.
- iii) The Appellant to let the Commission know whether the PIO has provided her the complete information or not in the next hearing.
- iv) The Appellant to be present in the next date of hearing without fail, **failing which the Commission will presume that the PIO has provided the Appellant with complete information and therefore, this appeal will be disposed of ex-parte.**
- v) The PIO to provide information to the Appellant when she presents herself at the office of the PIO AND the PIO to be present in the next date of hearing without fail, **failing which necessary action as provided under RTI, Act, 2005 shall be initiated against the PIO.**

- vi) Notice need not be sent to both the parties, as both the parties are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on **13th October 2026 at 2:30 PM (Evening)**.
