

## **ORDER**

The 3<sup>rd</sup> hearing held on 25<sup>th</sup> November' 2025' related to the APIC No-69/2025. The Appellant Shri Bengia Rina found absent without intimating to the Commission, the reason for his absence.

The PIO-cum-Executive Engineer, PWD, Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh, found absent for the consecutive 3<sup>rd</sup> time during the hearing, without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

The PIO absent consecutively 3<sup>rd</sup> time today, despite of notices being issued to the PIO on 19.02.2025, 08.05.2025 and 19.08.2025. The absence of the PIO consecutively has compelled the Commission to secure the attendance of the PIO to hear the appeal against him in the court of the Commission.

### **Heard the Appellant**

The Appellant stated before the Commission in the 2<sup>nd</sup> hearing on 08.05.2025 that he has not received any information(s) from the office of the PIO till date.

Taking serious note of the absence of the PIO for the 3<sup>rd</sup> consecutive time despite notice served and issued summons to him, **the Commission hereby order as follows;**

- i) To issue bailable warrant of arrest against the PIO-cum-Executive Engineer, (PWD) Sangram Division, Kurung Kumey District, for securing his attendance in the Fourth Hearing of this appeal, which is fixed on 31<sup>st</sup> day of March' 2026 at 2:30 PM.
- ii) To issue order to the Officer-In-Charge, Sangram Police Station, for executing the bailable warrant of arrest and to return the same and produce the errant PIO on the next date of hearing of this appeal which is fixed on **31.03.2026, at 2:30 PM, without fail**, before this court.
- iii) The copy of this bailable warrant of arrest be served to the Superintendent of Police, Kurung Kumey District for compliance.
- iv) The copy of this bailable warrant of arrest be served to the Deputy Commissioner, Kurung Kumey District for compliance.
- v) Notice for the next date of hearing be served to both the parties.

The Commission hereby orders;

The next date of hearing be fixed on 31<sup>st</sup> day of March' 2026 at 2:30 PM (Evening).


