RESPONDENT : The PIO o/o the Chief Engineer (Power), Transmission, Planning & Monitoring, Department of Power, Govt. of A.P. Itanagar,

ORDER

This is a Complaint under Section 18(1) of RTI Act, 2005 received from Shri Bengia Jayanta for denial of information by the PIO, o/o the Chief Engineer (Power), Transmission, Planning & Monitoring, Department of Power, Govt. of A.P. Itanagar, as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 06.03.2025.

Particular of information required:

(I) Related to all the information, Records, Official correspondences and procedures adopted for the appointment of Public Information Officer (PIO) and Assistant Public Information Officer (APIO) U/s 5 (1) & (2) of the RTI Act, 2005 for the office of the Chief Engineer (Power), Transmission, Planning and Monitoring Zone, Department of Power, Government of Arunachal Pradesh.

a) Subject matter of information required to be furnished:

1) Name Designation and Appointment copy / order of PIO and APIO

b) Period of Information : 2025

Records reveal that the appellant had requested for the aforementioned information from the PIO o/o the Chief Engineer (Power), Transmission, Planning & Monitoring, Department of Power, Govt. of A.P. Itanagar but the PIO, vide letter dt.08.03.2025, had refused to furnish the requested information on the ground that the RTI application dt.06.03.2025 submitted by the appellant is not as per the prescribed format notified by the notification dt.15.09.2025 and accordingly, disposed the case with liberty to prefer appeal before the higher authority, Govt. of A.P. There is, however, no record of the appellant's preferring his appeal before any higher authority, more importantly, the 1st appellate authority under section 19(1) of the RTI Act, 2005. But the appellant had filed complaint before this Commission under section 18 (1) of the RTI Act vide his complaint dt. 26.03.2025.

This complaint was, accordingly, registered in this Commission as complaint case No. APIC-05/2025 and listed for hearing on 16.07.2025 and summons were issued to the parties.

In the meanwhile, however, the appellant, vide his letter dt. 24.06.2025, had intimated this Commission that he had received the requested information from the PIO with which he is satisfied and, accordingly, prayed for dismissal of his complaint case as withdrawn.

In the premises as above no adjudication by this Commission on the complaint case No. APIC-05/2025 filed by the appellant, Shri Bengia Jayanta is warranted and resultantly, the said complaint is hereby closed as withdrawn on receipt of requested information and accordingly, the hearing of this complaint fixed on 16.07.2025 is **CANCELLED**.


