**ORDER**

- 1). This is a Complaint under Section 18(1) of RTI Act, 2005 filed by Mrs Illale Mitti, G/P New Hatiduba, Po/Ps Sunpura, Lohit District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-ERO (PR) Sunpura, Tezu, Lohit District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 02/12/2025 regarding "certified documents and status records pertaining to complaint dated 17/11/2025 involving the deletion of name from the electoral roll".
- 2). **The 1<sup>st</sup> hearing was held on 1<sup>st</sup> September 2026.** Shri Sotailum Bellai, PIO-cum-ERO (PR) , Tezu, Lohit District, Arunachal Pradesh, was absent. The Complainant, Shri Illali Mitti was represented by Shri Bajongso Mitti.
- 3). The representative of the Complainant informed the Commission that the PIO had not furnished information as sought and the FAA did not give proper adjudication, therefore they had also filed complaint along with an appeal.
- 4). The absence of the PIO, without prior intimation and justifiable reason, was viewed seriously by the Commission.
- 5). The Commission hereby directs **Shri Sotailum Bellai**, PIO-cum-ERO (PR) , Tezu, Lohit District, Arunachal Pradesh, to **SHOW CAUSE as to why Penalty should not be imposed on him under section 20 (1) of the RTI Act, 2005**, failing which disciplinary action shall be recommended under Section 20 (2) of the RTI Act, 2005. Reply to the Show Cause Notice should be submitted to the Commission on or before the next date of hearing.
- 6). **The next date of hearing is fixed on 13<sup>th</sup> October 2026 (Tuesday) at 1100hrs.**
- 7). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO is found absent the Commission will initiate penal action under section 20(1) of the RTI Act, 2005, and issue Arrest Warrant under section 18 (3)(a) of the RTI Act, 2005 to compel attendance. In case, the Complainant is found absent the case would be disposed of.
