**ORDER**

The 6<sup>th</sup> hearing held on **28<sup>th</sup> April' 2026'** related to the **APIC No-239/2024**. The Appellant Shri Pisa Tapam is present during the hearing before the Commission.

The PIO-cum-Executive Engineer, (EE), Hydro Power Lhou, Tawang Division-II, West Kameng District, Govt. of Arunachal Pradesh is present during the hearing before the Commission. The PIO stated that all the information as applied by the Appellant have been provided to the Appellant.

**Heard the Appellant;**

The Appellant stated that the PIO has furnished all the information(s) to him except one information which pertains to the letter from the PIO to him under Serial No. 10 for the subject of furnishing advertisement and local news paper copies for the tender floated to which the PIO has replied as Not Applicable (N/A) in his letter addressed to the Appellant on dated 31.03.2025.

If the PIO does not have the information with him regarding the same subject, he request the Commission to order the PIO to furnish it to him in an affidavit form stating the reason for non applicability for furnishing of information of the said advertisement published in local news paper for floating the tender for the works for which I have applied the application for the information.

After hearing both the parties, the Commission hereby pass the below orders;

- i) The PIO to provide an affidavit to the effect that the particular information is not available or the tender was not carried out for the said works and furnish it to the Appellant on or before the next date of hearing without fail.
- ii) The Appellant to intimate the Commission whether he received the affidavit from the PIO or not.
- iii) Both the Appellant and the PIO to be present in the next date of hearing without fail.

- iv) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing.

**The Commission hereby orders;**

**The next date of hearing be fixed on 14<sup>th</sup> day of July' 2026 at 2:30 PM (Evening).**
