



## **ARUNACHAL PRADESH INFORMATION COMMISSION**

**An Appeal Case U/S 19(3) of RTI Act, 2005**

### **ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Mamu Sono for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (WRD), Seppa Division, East Kameng District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 20.01.2025.

**A) Particular of information:** Regarding the C/o Retaining Wall at New Seppa near Hanging Bridge.

**B) Details of information required:**

1. Copies of MOA/MOU/agreement made in between WRD Department and concern company/firm for the Implementation above mentioned project.
2. Copies of total sanction amount order letter along with additional sanction amount.
3. Copies of executed contractors/firms name.
4. Copies of acceptance letter awarded to the contractors/firms.
5. Copies of financial, technical & final bidding documents.
6. Copies of quantity of work executed till date.
7. Copies of U/C submitted by the department to the State government/central government.
8. Copies of monitoring report, money receipt and completed report.
9. Copies of name of the third party monitoring agency along with guidelines for third party monitoring or implementation of the said project.
10. Copies of News paper cutting published in any local or national news paper agency as NIT with front page which were published by which news paper agency.
11. Copies of name and the place where the work executed implemented.
12. Copies of details of GST payment or bills paid or in details.
13. Copies of completion certificate of the work.
14. Copies of works experience, documents of the Firms /contactors.
15. Copies of P/A holder and name of firm/company in details.
16. Copies of colour videos, audios and photos clips were taken (before, during | | and after the work executed/completed.



17. Copies of GEO-TAGG (Before, during and after the work executed and / completed.
  18. Copies of work order and total numbers of tender participated list & total list of selected Firms for awarded the project.
  19. Copies of DIPR in details.
  20. Copies of all letter pad/DO letters by Hon'ble Minister, MLAs for awarding of contract work.
  21. Copies of NIT & NIQ submission letters.
  22. Copies of cheque issued to contractor, firm, agency and company with cheque no. in details.
  23. Copies of money paid to firm/contractors and balance amount.
  24. Copies of MB & Copies of payment Bill/Payment of Boucher's.
  25. Copies of present status of the project.
  26. Copies of any union, association, organization and individual complaint against the project if so far.
  27. Copies of EMD and copy of Bank Guarantee (BG)
  28. Copies of Security money deposited by the firms/contractors.
  29. Copies of Trading Licenses and profile details.
  30. Copies of comparative charts/statement charts.
- C) Period for which information required: inception to till today.

**Brief facts emerging from the appeal and decision:**

Records emerging from the appeal disclose that the Appellant, Shri Mamu Sono had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the Chief Engineer, Water Resource Department, W/Z, Govt. of A.P, Itanagar, the First Appellate Authority (FAA) under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dt. 24.02.2025. However, the appellant having failed yet again to obtain the information preferred second appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide memo of appeal dated 28.03.2025.

The records further reveal that the First Appellate Authority conducted a hearing on 20.03.2025 and vide order dt. 21st March, 2025 directed the PIO to furnish the required information as sought by the appellant within 30 (thirty) days from the date of issue of this order without fail which are furnishable as per RTI Act. 2005. But the appellant, apparently, failed to obtain the information. Hence, this 2<sup>nd</sup> appeal before this Commission.

This appeal was, accordingly, heard on 08<sup>th</sup> August, 2025, wherein both the appellant and the PIO, Er. Shri Gonong Pertin, EE were present in person.

The PIO brought in the requested documents / information which were handed over to the Appellant and who was directed to go through the same and report his satisfaction or other wise therewith within one week from today for further consideration of the appeal.

The appellant, accordingly, informed vide his letter dt.26.09.2025 that the PIO has furnished the requested information/documents with which he is satisfied. But the appellant expressed his intention to inspect the work site to verify the works executed as per the information he has received.

This commission considered the request of the appellant with reference to the provisions of section-2(j)(i) of the RTI Act, 2005 which is extracted hereunder:

*"2.(j) "right to information" means the right to information accessible under this Act which is held by or under the control of any public authority and includes the right to-*

*(i) Inspection of work, documents, records;"*

This Commission is of the opinion that the request of the appellant is in consonance with the provisions of law as above and as such he should be allowed to have the work site inspected. Accordingly, the PIO is directed to facilitate the inspection of work site by the appellant on a mutually convenient date.

This appeal is disposed of with the above direction.
