ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengia Mama, Jollang, Near Himalayan University, Itanagar, PO /PS Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO, O/o Directorate of Land Management, Itanagar, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/06/2025 regarding detail information of appointed Mandal, RK, & SK.
- 2). The 4th hearing was held on 14th July'2026 (Tuesday) at 1100 hrs. Shri Tara Raji, PIO-Cum-ADLM, Director, O/o Directorate of Land Management, Itanagar, Papum Pare District, Arunachal Pradesh and the Appellant Ms. Bengia Mama were present.
- 3). During the hearing, the PIO informed the Commission that the balance information was furnished to the Appellant on the 23rd June' 2026.
- 4). The Appellant agreed that she had received the information from the PIO on 23rd June' 2026, but had been ^{un}able to scrutinize the information and requested for 15 days time to verify the contents of the information.
- 5). The Commission directed the Appellant to go through the information and intimate her satisfaction and dissatisfaction to the Commission within the 15 days from the date of issue of the order. In case the Appellant failed to intimate the Commission within the stipulated time the case shall be closed without further notice. Based on the report of the Appellant the next date of hearing shall be fixed.
