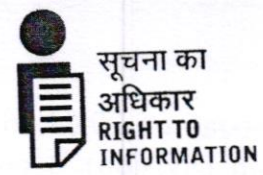

**An Appeal Case U/S 19(3) of RTI Act, 2005**  
**Case No. APIC- 704/2025.**

**APPELLANT** : Shri Bamang Pacho, IG Park, Itanagar.  
**RESPONDENT** : The PIO, o/o the EE (PWD), Koloriang Division, Kurung  
Kumey District.

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho for non-furnishing of 8(eight) point information each against 6(six) schemes by the PIO, o/o the EE (PWD), Sangram Division, Kurung Kumey District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.06.2025.

This appeal was heard on 13.02.2026 wherein the appellant, Shri Bamag Pacho and Shri Bini Tare, i/c RTI Cell representing the PIO, the EE (Sangram Division), were present.

This Commission, vide order dt.13.02.26, after hearing the representative of the PIO, who submitted that consequent upon bifurcation of Koloriang Division from the Sangram Division the handing and taking over of the charge of the Koloriang Division has been done on 14.10.2025 and that consequently for the pending RTI cases till 14.10.2025 in respect of the Koloriang Division, the EE (Koloriang Division) be summoned, directed *the PIOs of both the Sangram Division and Koloriang Division to appear in the next date on 18.03.26 to hear them and decide as to whose Division shall provide the requested information.*

As directed, on 18.03.26, Shri Bini Tare, i/c RTI Cell representing the PIO, the EE, Sangram (PWD) Division was present in person who produced the copy PIO's letter dt.16/10/2026 regarding the handing and taking over of the charges between the EE, Sangram Division and EE, Koloriang Division along with the list of RTI applications including the application dt.04.06.2025 which is the cause of action in the instant appeal. The appellant was also present in person but the PIO, Koloriang (PWD) Division was absent.

The representative of the PIO, Sangram Division, reiterating earlier submission of the PIO that the in view of handing over of the RTI cases including the 6(six) schemes in his RTI application dt. 04.06.25 to the EE, Koloriang Division, the PIO o/o EE (Koloriang Division) be summoned and heard henceforth.

In view of the factual position as evidenced by the POI's aforesaid letter and the list of RTI applications since handed over to the Koloriang Division, this Commission decided to summon the PIO o/o EE, Koloriang Division from now onwards and consequently, vide this Commission's order dt.18.03.26, the PIO o/o the EE, PWD, Koloriang Division, was directed to appear in the next hearing on 29<sup>th</sup> April 2026, along with the requested documents so as not to constrain this Commission to invoke the penal provision on RTI Act. 2005.

Today on 29.04.26, Shri Bini Tare, i/c RTI Cell representing the PIO, the EE (Sangram Division) is present in person. But the PIO, Koloriang Division is again absent. The appellant is also absent without any intimation.

The absence of appellant and the PIO, Koloriang Division has been taken seriously by this Commission and as such this Commission feels that this appeal should be closed. However, this Commission decides to await the requests from the appellant for further considerations, if any, of the appeal and unless and until this Commission receives any such request, the adjudication on this appeal shall stand suspended.
