An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC- 530/2026.

APPELLANT

: Shri Robin Rigam, Bank Tinali, Itanagar.

RESPONDENT

: The PIO, o/o the EE (PWD), Mechuka Division, Shi-Yomi District.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Robin Rigam for non-furnishing of below mentioned information by the PIO, o/o the EE (PWD), Mechuka Division, Shi-Yomi District as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 16.03.2026.

A. Details of information required:

1. **Administrative Approval & Sanction**
Certified copy of Administrative Approval and Expenditure Sanction for the construction of District Hospital Tato, Shi-Yomi Dist. (FY 2019-2020).
2. **Detailed Project Report (DPR)**
Certified copy of the complete Detailed Project Report (DPR) of District Hospital Tato.
3. **Technical Sanction**
Certified copy of the Technical Sanction order issued by the competent authority.
4. **Tender Process**
Certified copy of Notice Inviting Tender (NIT).
List of all contractors/agencies who participated in the tender process. Copy of tender evaluation report and work allotment order.
5. **Contract Agreement**
6. **Copy of MOU/Agreement** signed between the contractor and the concerned department for the construction of District Hospital Tato.
7. **Contractor Details**
Full name, address, license number and registration details of the contractor/agency awarded the work.
8. **Commencement of Work**
Certified copy of the work commencement order. Date of commencement of the project.
9. **Completion Report**
Certified copy of completion certificate issued by the department.
If the project is incomplete, provide reasons for delay and revised completion schedule.
10. **Financial Expenditure Details**
Complete statement of funds released for the project during FY 2019-2020.
11. **Bills & Vouchers**
Certified copies of all contractor bills, bill vouchers and measurement books (MB) related to the project.

12. **Payment Records**
Copies of payment receipts, cheque numbers, cheque names and bank transaction details through which payments were released to the contractor.
Department & Agency Responsible Name of the executing department/agency responsible for the project implementation.
13. **Inspection Reports**
Copies of inspection reports conducted by engineers or government authorities during construction.
14. **Photographic Evidence**
Provide photographs and video records of the project site during construction and current ongoing project status, if maintained in departmental records.
15. **Monitoring Authority**
Name and designation of officers responsible for monitoring and supervising the project.
16. **Public Accountability**
If any irregularities, delays, or financial objections were recorded in departmental audit reports, provide certified copies.
B. Period for which information is required: 2023 to till date.

Brief facts emerging from the appeal and decision:

Records in the appeal reveal that the appellant had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted him to file appeal before the First Appellate Authority (FAA), the Chief Engineer, (PWD), Central Zone (B), Pasighat, Govt. of A.P. under section 19(1) of the RTI Act vide their Memo of Appeal dt. 04.05.2026.

Record also disclose that the FAA, had attempted to conduct the hearing by issuing summon order dtd. 19.05.2026 but there is no record of hearing fixed on 09.06.2026.

But the appellant, apparently, having failed to obtain the information, preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dtd. 16.07.2026.

This appeal is, accordingly, listed today on 04.09.2026 wherein the appellant, Shri Robin Rigam is present in person while the PIO, Er. Shri Onit Borang appeared through VC.

Heard the parties.

The appellant, reiterating his demand for the requested information, pleaded for appropriate direction to the PIO to furnish the same and also demanded that penal action be initiated against the PIO if he fails to comply with the direction of this Commission.

The PIO, on the other hand, submitted that the requested information are ready for furnishing to the appellant.

This Commission, upon hearing the parties, more particularly the PIO who assured to furnish the requested information either through messenger or through post, directs him to furnish the information within 1(one) from the date of receipt of this order and the appellant shall, within 1(one) week thereafter, intimate the receipt thereof failing which this appeal shall stand closed without further notice.
