ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Ms. Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the Directorate office, SJETA, Banquet Hall, Itanagaras sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 02.03.2026.

A) Particular of information: c/o approach road for EMRS, Nyapin in Kurung Kumey District A.P

B) Details of information required:

1. Furnish a copy of Sanction Order/copy.
 2. Furnish a copy of the details of Executing Department.
 3. Furnish all the document in proper CTC in each page.
- C) Period for which information is sought for:** 2023 to 2024.

Brief facts emerging from the appeal and decision:

Records in the appeal reveal that the appellant Ms Bngia Mama had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted her to file appeal before the First Appellate Authority (FAA), the Director, Social Justice Empowerment and Tribal Affairs Department (SJETA), Banquet Hall, Govt. of Arunachal Pradesh, Itanagar, under section 19(1) of the RTI Act vide their Memo of Appeal dt.13.04.2026. But having failed yet again to obtain the information, she preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dtd. 04.06.2026.

This appeal is, accordingly, listed today on 28.08.2026 but both the appellant and the PIO are absent. However, the appellant, vide her letter dt.28.08.2026, intimated this Commission that she has received the requested information from the PIO and pleaded that the appeal be closed as such.

In view of the above, this appeal stands closed.

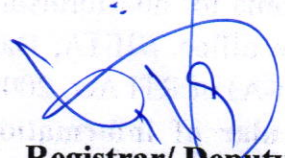
