ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Gangte Takuk, Leel, PO/PS Sangram, Kurung Kumey District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of A.P. o/o of Deputy Commissioner Changlang, District Changlang, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 10/06/2025 regarding **c/o 20 beds Hostel Building including Kitchen & Dining Hall with warden room.**

2). **The re-scheduled 1st hearing was held on 3rd February' 2026.** The PIO-cum-EE (RWD), Govt. of A.P. Rural Works Department Laaying Yangte Division, Kurung Kumey District, Arunachal Pradesh was represented by Shri Yangbiu Lika, APIO-cum-AE (RWD), Laaying Yangte. The Appellant Shri Gangte Tatuk was present.

3). The Appellant informed the Commission that the PIO had not furnished any information.

4). The APIO submitted that the information sought by the Appellant were regarding on ongoing project. The APIO also appealed to the Commission to give reasonable time to furnish information.

5). The Commission after hearing both the parties and going through the Form-A dated 10/06/2025 directed the PIO to furnish all the information sought by the Appellant within 24th February'2026.

6). The Commission directed the Appellant to contact the PIO , visit the office, and get complete information. After receipt of the information, the Appellant to intimate the Commission in writing, his satisfaction or dissatisfaction.

7). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within ten days from the expiry of above time given, the case would be disposed of.
