## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Changrang Rebe, ESS Sector, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Chayangtajo Division, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/01/2025 regarding c/o Ring Road at Sawa CO Hq. Township.
- 2). The 2<sup>nd</sup> hearing was held on 2<sup>nd</sup> Decembr' 2025 (Tuesday) at 1100 hrs. The Appellant Shri Changrang Rebe, was present. The PIO-Cum- EE(PWD), Ojing Pajing, Division, East kameng District was also present for the court hearing.
- 3). The Appellant informed the Commission that the PIO had not furnished the information as sought by him.
- 4). The PIO-Cum- EE(PWD), Ojing Pajing, Division, East Kameng District, Arunachal Pradesh submitted that due to sudden demise of his maternal uncle on 20<sup>th</sup> October' 2025 he could not attend the 1<sup>st</sup> hearing held on 21<sup>st</sup> October' 2025 despite his readiness to attend the court with all documents, and therefore, his absence from the hearing be condoned on compassionate ground.
- 5). The PIO-Cum- EE(PWD), Ojing Pajing, Division, East Kameng District, Arunachal Pradesh had brought all the information as required by the Appellant and handed over the same to the appellant in presence of the Commission.
- 6). The Commission directed the Appellant to go thorough the information and inform his satisfaction and dissatisfaction to the Commission within 15 days from the issue of the order, failing which the case shall be disposed without further notice.
- 6). The next course of action shall be determined based on the report of the Appellant.
