### ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Miss Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the Director, Women and Child Development Department, Itanagar, Papum Pare District Govt. of Arunachal Pradesh as sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 13.05.2025:

**Brief facts :**

Records reveal that the appellant Miss Bengia Mama had requested the PIO for the above mentioned information but could not obtain the same within the statutory period of one month which prompted her to approach the First Appellate Authority, the Director, Women and Child Development Department, Itanagar, Govt. of A.P. Having failed yet again to obtain the sought for information from the PIO, she filed her Second Appeal before this Commission under section 19(3) of the RTI Act.

Accordingly this appeal is listed on 8<sup>th</sup> October, 2025 at 10.30 AM for hearing.

In the mean time, however, the Commission is in receipt of letter dated 29<sup>th</sup> Sept. 2025 from the appellant Miss Bengia Mama withdrawing her appeal intimating that she had received all the documents from the concerned PIO on 26<sup>th</sup> September, 2025 and that she is satisfied with the same and further, requested this Commission to close this Appeal.

In the premises as above this appeal is closed and the hearing of the appeal fixed on 08.10.2025 stands cancelled.


