- Certified Copy of Place of posting of all the contingency/causal staffs serving under your Division and Sub-Division.
- Certified copy of recruited advertised/Publication on 3 No, names of local newspaper cutting, electronic media, print media, news channels etc. of all the contingency/causal staff serving under your Division and Sub-division.
- Certified copy of written examine mark obtained/walk interview along with videography/photography, if conducted the interview of all the contingency/casual staff serving under your division and sub-division.

- (g) Certified Copy of present strength of all the contingency/casual staff under serving your Division and Sub-Division.
- (h) Certified Copy of new strength vacate of all the contingency/casual staff serving under your division and sub-division.
- (i) Certified copy of Approval from competent authority of CE/SE recruited/advertised of all the contingency/casual staff serving under your division and sub-division.
- (j) Certified copy of all the supporting documents like educational qualification, Aadhar card, ST, PRC, SC, OBC, Bank Passbook etc. of all the contingency/casual staff serving under your division and sub-division.
- (k) Certified Copy of total sanction strength of all the contingency/casual staff serving under your division and sub-division.
- (l) Certified copy of Recruitments rule (RR) of the contingency/casual staffs approval from Administrative Reforms (AR) Department Govt. of (AP).
- (m) Certified copy of attendance registers and active contact No. of all the contingency/casual Staffs serving under your division & sub division.
- (n) Certified copy of that employee who transferred from other district under Arunachal Pradesh to all the contingency/casual staff serving under your division and sub-division.
- (o) Certified copy of finance concurrence from Finance Department of Govt. of (A.P) for making the payment/disbursement to contingency/casual staff serving under your division & sub-division.
- (p) Certified copy of officer Name along with working contact Number of Chief Engineer and Superintending Engineer, Executive Engineer who appointed to all the contingency/Casual staff serving under your division and sub-division.
- (q) Certified Copy of Service identity card along with sign & seal from competent authority and active contact No. of all the contingency and casual staff serving under Division and sub-division.
- (r) Certified copy of Note sheet/OM/Recommendation letter from Ministers/ Advisor to HM, HMLA, s Chief Engineer, Superintending Engineer etc. to all the Contingency/Casual staff serving under your division and sub-division.

**Decision:**
