ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Wangnon Wangnow, Forest Colony Longding, District Longding, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Department of Rural Work, Longding Division, District Longding, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/02/2025 regarding Road from 1.54 km point of BRTF Konnu to PMGSY Road to Konsa.
- 2). The 3rd hearing was held on 3rd February' 2026. Shri R.W. Zimik, the PIO-cum-EE (RWD), Govt. of A.P., Longding Division, Longding District, Arunachal Pradesh, had appeared before the Court through video conferencing. The Appellant Shri Wangnon Wangnow had appeared in person before the Court.
- 3). The PIO was also directed to furnish all the available information to the Appellant on 10th February'2026 and in case the information were not available the PIO was to give justifiable reasons in writing.
- 4). The Appellant vide letter dated 10/02/2026 has appealed for compensation of Rs. 40, 000/- (Rupees Forty Thousand) only under section 19(8) (b) of the RTI Act 2005.
- 5). The Commission to hear from both the parties decided to fix a date of hearing.
- 6). **The next date of hearing is fixed on 31st March'2025 at 11am.**
