ORDER

The 1st hearing held on **24 February' 2026'** related to the **APIC No-748/A/2025**. The Appellant Shri Lokam Namdu is present during the hearing before the Commission.

The PIO-cum-DFO, Kra-Daadi, Forest Division, Kra-Daadi District, Govt. of Arunachal Pradesh is represented by Shri Raja Debom, Head Assistant of the PIO present with an authority letter from the PIO during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that he has not been provided with the information(s) till date.

Heard the representative of the PIO;

The representative of the PIO stated that the information(s) as sought by the Appellant have been dispatched through post office, through registered post on 28th day of June' 2025.

The documents sent through post office have also been brought to the court and handed over to the Appellant in the court of the Arunachal Pradesh Information Commission (APIC).

The Commission ordered the Appellant to receive the information(s) and go through the information(s), to see whether complete information(s) have been furnished to him or not.

Under the above stated circumstances the Commission hereby order as follows;

- i) The Appellant to go through the information(s) as furnished by the PIO in the court of the Commission and report to the Commission if he has been provided with the complete information or not, in the next date of hearing.
- ii) The PIO to be present in the next date of hearing without fail to verify from the Appellant the receipt of complete information(s) or not.
- iii) In failure of the PIO to attend the next date of hearing necessary action as provided under the RTI, Act, 2005 will be initiated against the PIO.
- iv) The Appellant to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.
- v) Notice need not be send to both the parties as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 14th day of May' 2026 at 10:30 AM (Morning).
