ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Changrang Rebe, ESS Sector, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Chayangtajo Division, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/01/2025 regarding c/o Ring Road at Sawa CO Hq. Township.
- 2). The 3rd hearing was held on 3rd March' 2026. Er. Ojing Pajing, PIO-cum-EE (PWD), Chayangtajo Division, East Kameng District, Arunachal Pradesh and the Appellant Shri Changrang Rebe were present.
- 3). The Appellant submitted that the PIO had not furnished information for Sl.no. 1, 3, 4, 7 & 11 as sought at Form A dated 25/01/2025.
- 4). The PIO submitted that he did not receive any letter from the Appellant regarding the incomplete information, it was acknowledged from the office of the Commission. The PIO appealed the Commission to give one week time to furnish complete information.
- 5). The Commission directed the PIO to furnish information in PDF form to the Appellant and also intimate the Commission of his action taken within seven days from the date of issue of this order.
- 5). In case incomplete information is furnished by the PIO, the Appellant is asked to give the detail list to the PIO with intimation to the Commission or in case complete information is furnished, the Appellant is directed to intimate his satisfaction or dissatisfaction to the Commission within fifteen days from the date of issue of this order, failing which the case shall be disposed of.
