**ORDER**

The 4<sup>th</sup> hearing held on **5<sup>th</sup> May' 2026'** related to the **APIC No-96/2024**. The Appellant Shri Tap Tapum Hiyang is present during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), RWD, Jamin Division, Kra-Daadi District, Govt. of Arunachal Pradesh is represented by Shri Byabang Takar, Junior Engineer (JE)-cum-APIO, Jamin Division during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated that no information have been furnished by the PIO till now. Whereas, the APIO in the last hearing on 10<sup>th</sup> day of February' 2026 assured that he will provide the information as available with the office of the PIO before the next date of hearing.

**Heard the APIO;**

The APIO stated that whatever information available at the office of the PIO have been brought to the court of this Commission today to be handed over to the Appellant and requested the court to let the Appellant receive the information from him.

After hearing both the parties the Commission hereby orders;

- i) The Appellant to receive the information that have been brought to the court by the APIO and after going through the information to let the Commission know that the complete information as applied have been furnished to him or not.
- ii) To ascertain the receipt of the complete information as applied by the Appellant a next hearing is ordered and therefore, the Appellant is ordered to attend the hearing in the next date of hearing without fail, failing which this court will presume that the complete information have been furnished to him by the PIO, and therefore, this appeal will be disposed ex-parte.
- iii) The PIO to be present in the next of hearing without fail, failing which necessary action as provided under RTI, Act, 2005 will be initiated against the PIO.

**The Commission hereby orders;**

**The next date of hearing be fixed on 16<sup>th</sup> day of July' 2026 at 10:30 AM (Morning).**


