ORDER

The 5th hearing held on **28th October, 2025** related to the **APIC No. 647/2023**. The Appellant Shri Tamchi Gungte is present during the hearing before the Commission.

The PIO-cum-Executive Engineer, PWD, Basar Division, Leparada District, Govt. of Arunachal Pradesh is represented by Shri Kayi Gadi (Assistant Engineer), PWD, Tirbin Sub-Division during the hearing before the Commission.

The Superintendent of Police (SP) Leparada District submitted the compliance report of the execution of Bailable Warrant of Arrest against the PIO-cum-Executive Engineer, PWD, Basar Division.

- iii) To ascertain the above facts the Commission fixed another date for hearing.
- iv) Notice need not be issued to both the parties as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 5th March' 2026' at 10:30 AM (Morning).
