### Appeal Under Section 19(3) RTI Act, 2005

### ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village Seppa, Po/Ps-Seppa, East kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-EE(PWD), O/o EE (PWD), Bomdila Division, West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 10/07/2025 regarding **Category of work charged (W/C) serving under Bomdila Division.**
- 2). **The 1<sup>st</sup> re-scheduled hearing was held on 3<sup>rd</sup> February' 2026.** Er. Thanu Rangradu, PIO-EE(PWD), O/o EE (PWD), Bomdila Division, West Kameng District, Arunachal Pradesh was absent. The Appellant Shri Ashok Sangbia was present.
- 3). The Appellant submitted that the PIO had not furnished any information as sought for in the Form-A dated 10/07/2025.
- 4). The Commission viewed the absence of the PIO, without any justifiable reason, seriously.
- 5). The Commission hereby directs Er. Thanu Rangradu, PIO-EE(PWD), O/o EE (PWD), Bomdila Division, West Kameng District, Arunachal Pradesh to **SHOW CAUSE as to why penalty should not be imposed on him under section 20 (1) of the RTI Act, 2005** for violation of the RTI Act'2005. Failure to respond, the Commission shall be compelled to invoke Section 18 (3)(a) of the RTI Act'2005 i.e. Arrest Warrant to compel attendance before the Commission's Court and also recommend disciplinary action under section 20(2) of the RTI Act' 2005.

6). Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the PIO found absent the Commission will initiate penal action under section 20(1) of the RTI Act, 2005, and issue Arrest Warrant under section 18 (3)(a) of the RTI Act, 2005 to compel attendance. In case Appellant is found absent the case shall be disposed of without any further notice.

6). The next date of hearing is fixed on 17<sup>th</sup> March'2026 (Tuesday) at 1100hrs.
