## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengia Mama, Jollang, Near Himalayan University, Itanagar, PO /PS Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- DLRSO, Capital Complex, Itanagar, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/05/2025 regarding Land allotment and its related details of Power House, Niti Vihar, Itanagar.
- 2). The 1<sup>st</sup> hearing was held on 25<sup>th</sup> November' 2025. Ms Byabang Naemeh, PIO-cum-DLRSO, Capital Complex, Itanagar, Papum Pare District, Arunachal Pradesh and the Appellant Ms Bengia Mama were present.
- 3). The PIO submitted that she could not find any records of the information sought by the Appellant in the office. In this regard a letter had been forwarded to the Power Department but till date Power department has not replied. A copy of the letter was sent to the Appellant too.
- 4). The Appellant informed that she had not received such a letter till date.
- 5). The Commission directed the PIO to once again write to the Power Department under intimation to the Commission and also furnish a copy to the Appellant.
- 6). The Commission also hereby directs the authority of the Power Department to furnish information to the DLRSO Capital Complex or directly to the Appellant within fifteen days from the date of issue of this order.

- 7). The Commission asked the Appellant to approach the PIO or the concern authority of the Power Department and collect information. After receipt of information the Appellant was directed to intimate his satisfaction or dissatisfaction by 24<sup>th</sup> December 2025.
- 8). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within ten days from the expiry of above date given, the case would be disposed of.
