ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PHE & WS), Tezu Division, Lohit District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 20.09.2025.

A) **Particular of information:** C/o "total list of completed Works/ projects sponsored by State fund/ Central fund or both (such as SIDF/ BE/ RE/ RIDF/ SADA/ ADA/ MLALAD/ MPLAD/ SPA/ Article 275(1)/ PMJVK/ CRIF/ PMDeVine/ NEC/ NESIDS / Non-BADP, SASCI/ FMBAP/NRDWM/ SBM, Maintenance works etc), executed under the concern division" from the financial year 2016-17 to 2025-26.

B)Details of information require:

1. Furnish the certified copy of Total list of works/projects completed by the division under various scheme head mentioned above (state/central scheme or both as mentioned above) for each financial year from 2016-17 to 2025-26.
2. Furnish the certified copy of Sanction order/ Administrative Approval (AA) & Expenditure Sanction (ES) of each completed projects in respect of serial No. 1 mentioned above for each financial year from 2016-2017 to 2025-2026.
3. Furnish the certified copy of Technical Sanction (TS) of each completed projects in respect of serial no. 1 mentioned above for each financial year from 2016-17 to 2025-26.
4. Furnish the certified copy of Agreement made between the Contractor and Executing Agency, for each completed projects/works from the financial 2016-17 to 2025-26.
5. Furnish the certified copy of Work Order (with amount mentioned) issued to the contractor with respect to serial no. 1. (only for the work awarded in work order form) 2016-17 to 2025-26.
6. Furnish the Details of fund Surrendered to the Govt. Head Account, in respect of serial no. 1 of my form-A
 - a) Remaining balance amount after A/A E/S and TS has been done. (Enclosed the proof of surrender such as Challan copy or whichever method has been used.)
 - b) Remaining Balance amount after TS and Contract Agreement of the project/work. (Enclosed the proof of surrender such as Challan copy or whichever method has been used)

7. Furnish the Details of Expenditures of fund if been utilised, in respect of serial no. 1 of my Form-A:-
 - a) Remaining balance amount after A/A E/S and TS has been completed. (Enclosed the proof of Expenditure.)
 - b) Remaining Balance amount after TS and Contract Agreement/work order amount of the projects/works. (Enclosed the proof of expenditure)
8. Furnish the certified details of Officer (name & Designation) who authorized/approve the surrender process of fund in respect of serial no. 6 of the Form-A.
9. Furnish the certified details of Officer who authorized/approve the expenditures of fund in respect of serial no. 7 of Form-A.
10. Furnish the Rules followed by the Division Officers (under CPWD works manual/ any other etc.) that authorize the officers to make an expenditures of fund beyond the Contract agreement/Work Order amount in respect of the projects/works.
11. Furnish all the above documents with CTC & proper manner (i.e. in serial wise with properly Index and proper paging of each financial year).

This appeal was heard on 27.05.2026 wherein the PIO, Shri Nure Linggi, EE, Tezu PHE Division was present though VC but the appellant did not attend without any intimation.

This Commission upon hearing the PIO that the appellant, despite his (PIO') advice to collect the information / documents, did not turn up to collect the documents and on perusal of his letter dt.27.11.2025 to the appellant and also taking into account the absence of the appellant in the hearing, had to conclude that the appellant is no longer interested in the requested information / documents. Resultantly, this appeal was closed as not being interested by the appellant.

This Commission, however, is now in receipt of letter dtd 02.07.2026 from the appellant, Shri Tamchi Gungte (as reproduced hereunder) intimating that the PIO's statement that he was informed multiple times to collect the documents is not completely true . The appellant has, hence, requested this Commission for adjudicating the appeal under section 19 (3) of the RTI Act.

"Respected sir,

I am writing this letter to inform The you sir that in the previous hearing, the PIO have given statement that I was informed multiple times to collect the documents, which is not completely true. So, I request the honourable Judge to provide me another date of nearing to hear the matter from both the party.

Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.


