**Information sought:**

The appellant filed an RTI application dated 01.04.2025 seeking following information regarding "expenditure details of Rs. 36,01,05,940/- for implementation of the items under CA, NPV and CAT plan component of state CAMPA AoP Vol-I from 21<sup>st</sup> March 2023".

**Details of information required:**

1. Furnished copy of Sanction order of the Project.
2. Furnished copy of NIT done against the Project.
3. Furnished copy of fund disbursement to each RFO in respect of the Project.
4. Furnished copy of utilization and completion certificate against the Project.
5. Furnished colouring photocopy of physical work exaction against the Project.
6. Furnished all the bank transaction and payment made to any agencies against the project with proper bank statement record.

The following were present.

**Appellant** : Absent. No intimation for reason of absent.

**Respondent PIO**

: Absent. Miss Anu Nalo, RFO represented the PIO. She states that she has brought the information to deliver to the appellant.

**Decision:**

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the representative of the PIO observes that the FAA – Chief Conservator of Forest (WZ), Banderdewa has issued a hearing notice on 23.7.2025 for hearing on 12.08.2025 but a copy of judgement order is not on record. The appellant is directed to collect the information from the office of the PIO within ten days from the date of issue of this order and submit status of information received by him to this commission within fifteen days from the date of issue of this order.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
