**Information sought:**

The appellant filed an RTI application dated 14.04.2025 seeking following information regarding C/o "List of Project/work sanctioned under Article 275 (1) of the constitution of India, by the Ministry of Tribal Affairs Govt. of India during the financial year 2018-20.

**The total list of work/ projects as follows:**

1. Establishment of large cardamom garden at Deya colony Tirbin, Leparada Dist. (2019-20).
2. Establishment of large cardamom garden at Sago, Lower Siang dist. (2018-19).
3. Establishment of large cardamom garden at Piri, Lower Siang Dist. (2018-19).
4. Establishment of large cardamom garden at Saken Under Tirbin, Lower Siang Dist. (2018-19).

5. Construction of foot Suspension bridge over river Rime (120m span) and a porter track in between Deke PMGSY Road to Liromoba PWD road at BegeYardoi, Yase, Essi lite and Essikarte under West Siang Dist. (2019-20).
6. Cultivation of large Cardamom Garden at Deke Village in West Siang District. Area 200 Hectares; Beneficiaries -local daily wages. (2017-18).
7. Establishment of Large Cardamom Garden at Yegri Village in west Siang Dist. Area 84 Hectares; beneficiaries-44. (2017-18).
8. Portar Track from SodoDoke BRTF road to SibeSiru NLCPR road and Construction of FSB over River Sibun at RagiDoke, MobaDoke, Sibe and Siru village in west Siang Dist. (2017-18).
9. Medical Sub-Centre and Dispensary Building with Boundary wall at Tai, Essi-Rite, ChekorLombi and badak and Dorputu in West Siang District. 5 units, Units cost Rs 20 Lakhs (2017-18).

3. Furnish the certified copy of Proof (such as Voter ID and PRC) that the tender winning firm Domicile status within the Territorial jurisdiction of that Constituency Assembly as per District Based Entrepreneur and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020.
4. Furnish the certified copy of Technical Sanction done by the concerned Authority for the projects as per financial rules.
5. Furnish the certified copy of Utilization Certificate.
6. Furnish the certified copy of Notice Inviting Tender (NIT) with respect to the subject mentioned above.
7. Furnish the certified Progress Report of the projects in Physical and Financial section till date.
8. Furnish the certified copy of Completion certificate of the project.
9. Furnish the certified copy of Newspaper in which NIT was published (At least 3 newspaper name (one National & 2 Local)) along with date of publication of Newspaper, as per Government approved Order (Order No. IPR/ADVT (Advt. Policy)-37/2016, Dated 30th January, 2018 by the Secretary to the Govt. of Arunachal Pradesh Information and Public Relations Department, Itanagar).
10. Furnish the certified copy of Work Specification of the projects.
11. Furnish the certified copy of documents submitted by tender participant for Technical Bid.
12. Furnish the Name of Firms who won the Tender work with respect to the subject mentioned above.
13. Furnish the Name of Officers and their Designation at the Time of monitoring the work.
14. Furnish the certified copy of Contractor Registration, of the tender participant and tender winning Firm.
15. Furnish the certified copy of Contractor Enlistment Order (Civil/Composite Category as per the nature of work), of tender participant and winning Firm.
16. Furnish the certified copy of EMD and Security money deposited by all the tender participant.
17. Furnish the certified Integrity Pact submitted by the tender participant.
18. Furnish the certified Affidavit copy Sworn before a Competent Magistrate to the effect that he/she (tender participant), does not have 2 (Two) or more incomplete ongoing

commitment (projects/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dtd. 01-08-2018 and Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentive, Development and Promotion) rules, 2015 & 2020).

19. Furnish the certified documents submitted by tender participant and winning firm, i.e. copy of completed Three similar work each of value not less than 40% of the estimate cost or Completed Two Similar work each of value not less than 60% of the estimated cost or Completed One similar work of value not less than 80% of the estimated cost along with the Completion Certificate issued by the Engineer in Charge duly Countersigned by the Concerned Superintending Engineer and Chief Engineer, in the last 5 years ending last day of the month previous to the one in which the tenders are invited.
20. Furnish the certified copy of Acceptance letter for Tender work by the Executing Agency to the tender Winning Firm.
21. Furnish the certified copy of Work Order given to the Contractor by the Executing Department.
22. Furnish the Agreement Copy made between the Contractor and the Executive Agency for the projects mentioned above.
23. Furnish the certified copy of all Photographs of work items (Glossy paper) before starting of work.
24. Furnish the certified copy Photograph (Glossy Paper) of project after completion of work.
25. Furnish the Geo Coordinate information before the start of projects and after the start of the project mentioned above.
26. Furnish the certified Payment Details (Cheque no., voucher, PFMS etc. (Which ever method is used of payments)) of the project till date.
27. Furnish the certified Solvency certificate certified by the Bankers, submitted by all the tender participant.
28. Furnish the certified Credit facility from Bankers (10% of the tender value) submitted by the tender participants.
29. Furnish the certified Affidavit to invest cash up to (25% of tender value) submitted by the tender participant.
30. Furnish the certified copy of Utilization Certificate for the amount exempted in the NIT from the Total Sanctioned amount.
31. Furnish the certified Photocopy of Physical Verification by the Nodal Department before releasing the Final Payment along with proper date as per sanction order guidelines.
32. Furnish the certified copy of Physical Verification report by the Nodal Report as per Sanction Order Guidelines.

Order of the 1<sup>st</sup> hearing - *"The FAA - the Project Director / Deputy Director (RD), Leparada District, Basar was directed to invariably conduct a hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter pass reasoned and speaking order on merit within three weeks from the date of issue of this order under intimation to this commission."*

The following were present.

#### **Appellant**

: Present. He states that the FAA has conducted hearing of the first appeal on 01.05.2026 wherein he himself and the PIO has attended.

The FAA has directed PIO to furnish the information within two weeks. But, the judgement order not yet received.

**Respondent PIO** : Absent.

**F A A** : Absent.

**Decision:**

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, hearing the appellant, observes that the FAA cum PD/Deputy Director RD Department, Basar has issued notice on 20.4.2026 for hearing on 01.05.2026. But the judgement order is not in record. The absence of the FAA and PIO in today's hearing without any intimation of reason thereof is a violation of statutory duty of a public authority under the provision of RTI Act, 2005. The PIO is directed to furnish the information to the appellant within two weeks from the date of issue of this order under intimation to this commission and attend next hearing in person or through authorised representative along with a copy of judgement order of the FAA, if issued. Failure to do so shall entail for award of appropriate compensation to the appellant including further proceeding against PIO for penal action under the provision of RTI Act, 2005.

The appellant shall serve a copy of this order to the PIO, obtain written acknowledgement and submit a copy of it to this commission.

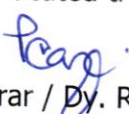
