ORDER

The 3rd hearing held on **16th day of July' 2026'** related to the **APIC No-507/A/2025**.
The Appellant Miss Bengia Mama is present during the hearing before the Commission.

The PIO-cum-BDO, CD-Block Parsiparlo, Kurung Kumey District, Govt. of Arunachal Pradesh is represented by Shri Challo Take, Extension Officer (RE), CD-Block Parsiparlo, Kurung Kumey District, Govt. of Arunachal Pradesh during the hearing before the Commission through online mode.

Heard the Appellant;

The Appellant stated that she has posted the Form-A through post at Itanagar Post Office and collected the details that the letter has been delivered at Palin post office but proper receipt of the PIO has not been mentioned.

Heard the representative of the PIO;

The representative of the PIO stated that they have not received the Form-A of the Appellant till now, and therefore, the office of the PIO do not have any idea as to what information(s) have been sought by the Appellant.

After hearing both the parties the Commission hereby order as follows;

- i) The Appellant to send the Form-A to the representative of the PIO through WhatsApp Messaging App at the mobile telephone Number- 841386688 by properly scanning the Form-A.
- ii) The PIO, after the Form-A is delivered through WhatsApp at the number of his representative Shri Challo Take to provide the information to the Appellant within **One Month** from today.
- iii) The Appellant to collect the information from the office of the PIO after **One Month** from today and so, to inquire for the information(s) are ready or not, and on being readied, the Appellant to collect the information from the office of the PIO.
- iv) The PIO to provide the information and intimate the Commission as well as the Appellant about the information furnished within One Month from today.

- v) The Appellant to be present in the next hearing without fail, failing which the Commission will presume that She has received the complete information(s) from the PIO, and therefore, the Commission will hear and determine this appeal ex-parte, by way of disposing this appeal.
- vi) The PIO to be present in the next date of hearing without fail, failing which the Commission will initiate action as provided under RTI, Act, 2005 against the PIO.
- vii) Notice need not be sent to both the parties as they are present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 29th day of September' 2026 at 2:30 PM (Evening).
