### Appeal Under Section 19(3) RTI Act, 2005

### O R D E R

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Sengman Ronrang, Sinwang Village, PO/PS Manmao, District Changlang, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DLRSO, Govt. of A.P. Changlang HQ, District Changlang, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 09/07/2025 regarding Border Road from 'O' point via Tengman village to Hetman village under Manmao circle.

2). **The 1<sup>st</sup> hearing was held on 3<sup>rd</sup> February' 2026.** Shri Taba Torum, PIO-cum-DLRSO, Govt. of A.P. Changlang HQ, District Changlang, Arunachal Pradesh appeared before the Court through Video Conferencing. The Appellant Shri Sengman Ronrang was present in person.

3). The PIO submitted that some of the information cannot be furnished as they are related to defence and the work was being carried out by the Border Road Organization (BRO). Government of Arunachal Pradesh vide memo no. Secy (LM)-06/2021/10 dated Itanagar the 15<sup>th</sup> March'2021 had directed not to share any information through RTI to any person relating to the Defence for the national security reasons. Also, the HGB & GBs vide letter dated 15/07/2025 had appealed to the Deputy Commissioner, Changlang not to disclose information under RTI regarding compensation matter for security and safety of the beneficiaries.

4). The Appellant submitted that though the work is being carried out by the BRO, the land acquisition and compensation were carried out under the Deputy Commissioner (D.C.) and DLRSO. So, the total amount of compensation, list of beneficiaries and the compensated amounts may be furnished by the PIO.

5). The Commission in view of Section 24 of the RTI Act 2005 read in conjunction with government circular and representation of the GBs, hereby directs the PIO to furnish only the list of beneficiaries to the Appellant, the information that does not fall under exemption category.

6). The Appellant was directed to intimate the Commission in writing, his satisfaction or dissatisfaction after, receipt of the information.

7). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within twenty days from the date of issue of this order, the case would be disposed of.
