ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Donik Roru and Khyoda Tacha for non-furnishing of below mentioned information by the PIO, o/o the PD, DRDA, Govt. of A.P, Kra Daadi District, Palin as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 18.05.2025.

A. Particulars of information: Under DC Unif Fund, C/o Porter Track from Gallang Village to Nyoya under Chambang Circle, Kra Daadi District 2022-2023.

B. Details of Information: -

Brief facts emerging from the appeal:

Records in the appeal revealed that the appellants had filed their RTI application dt.08.05.2025 through the Post Office but there was no clear and proper record of the receipt of the application by the o/o the PIO. However, the appellants, filed their 1st appeal before the Deputy Commission, Kra-Daadi, District, Palin, the First Appellate Authority (FAA) vide their Memo of Appeal dt.30.07.25, apparently, due to non-receipt of the information from the o/o the PIO.

The appellants filed their 2nd appeal before this Commission under section 19(3) of the RTI Act vide Memo of Appeal dt.22.10.2025 on failing to obtain positive response from the FAA.

It was, however, noticed from the appeal that the D.C, the FAA did not adjudicate on the appeal as mandated under section 19(1) of the RTI Act, 2005. As such this appeal was remanded to the D.C, Kra-Daadi, Palin, the FAA vide this Commission's order dt.27.02.2026 for adjudication and passing an appropriate order in speaking form within 1(one) month from the date of receipt of this order. The appellants were also directed that if they felt aggrieved by the decision of the FAA, they may prefer their 2nd appeal before this Commission within 90(ninety) days from the date of the FAA's order for which no fees need be paid to this Commission.

This Commission, is now in receipt of letter dt. 03.07.2026 from one of the appellants, namely, Shri Donik Roru complaining that the o/o the Deputy Commissioner, Kra Daadi district , Govt. of A.P., Palin, the FAA did not take any action on the appeal despite the direction from this Commission and therefore requested for admitting and hearing the appeal. The extract of the appellants' letter is as under:

"Sir,

With due respect and humble submission, I would like to you to inform you that the PIO, PD, (DRDA) and DC, Kra-Daadi District, has not taken any response thus far for furnishing information u/s section of RTI Act, 2005 as related to the aforementioned APIC No. That's why being sought information from your esteemed office.

Therefore, you're requested to kindly admit this and keep continued for hearing as mention above.

This is for kind information and necessary action please.

This Commission perused the letter from the appellants as above and decides to hear the appeal in terms of its order dt.27.02.2026 and accordingly, lists this appeal on 07.08.26. In the meantime, the PIO is directed to furnish the requested information to the appellants and report the compliance thereof on 07.08.2026 so as not to constrain this Commission to invoke the penal provisions of the RTI Act, 2005.

Take notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence, including closure of the appeal.


