ORDER

The 4th hearing held on 16th July'2026 related to the **APIC No-96/202(Appeal)**. The Appellant Shri tap Tapum Hiyang, present during the hearing but the PIO-Cum_ EE (RWD) Jamin Divison District Kra-Daadi, Govt of Arunachal Pradesh, absent during the hearing despite being notified of todays hearing in advance on 5th May'2026. Wherein his representative Shri Byabang, Takar, JE -cum- APIO, was present on the same date when the next date of hearing was pronounced in the open court of this Commission.

Heard the Appellant;

The Appellant stated before the Commission that out of 6(six) information that he has applied from the PIO, he has been provided the information listed under sl.no-5 & 6 only but the information listed under Sl No.,-1,2,3 & 4 of his form 'A' have not been provided to him till now. To be specific the information that have not been provided to the Appellant are ;

- i) **Issue of T/S Copy** (ii) **NIT Published in local news paper copy** (iii) **Name of Firm/Proprietor to whom work awarded** (iv) **The progress report of the Project.**

After hearing the Appellant and going through the information that was furnished to him by the PIO the Commission hereby observe that the submission of the Appellant is true and correct. With the above observations, **the Commission hereby order as below;**

- i) The PIO -Cum_ EE (RWD) Jamin Division Govt. of Arunachal Pradesh to provide the information listed under sl. No. 1,2,3& 4 in the form 'A' on or before the next date of hearing without fail, **failing which the Commission will panelize the PIO appropriately.**
- ii) The PIO to attend the hearing on the next date as pronounced today without fail, **failing which necessary action as provided under RTI Act 2005 will be initiated against the PIO.**

- iii) The Appellant to be present in the next date of hearing without fail, failing which the Commission will presume that the Appellant has received the information completely from the PIO, and thereby absence of the Appellant will compel the Commission to hear and determine this appeal ex-parte by way of disposing this appeal in the next date of hearing.
- iv) To send notice to the PIO-Cum-EE (RWD) Jamin Division Govt of Arunachal Pradesh.
- v) The next date of hearing has been intimated to the Appellant as he is present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 29th Sept'2026 at 2:30 PM (Evening).
