The following were present.

Appellant : Present. She states that information furnished by the PIO is incomplete as per RTI application at Sl.no. 3,4,6,10 & 12.

Respondent PIO : Absent. Without any intimation to this commission court.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the appellant, observes that the FAA – Chief Conservator of Forest, Central Zone Pasighat has heard and disposed of the appeal case on 20.03.2026 assuming that the appellant is no longer interested to pursue the case as she has neither responded to the PIO's letter dated 17.2.2026 nor attended the hearing conducted on 20.03.2026.

Today appellant is present and he states that the PIO has furnished incomplete information sought as per his RTI application.

The PIO is absent in today's hearing without any intimation of the reason thereof, which is a violation of statutory duty of a public authority under the provisions of RTI Act, 2005.

Ex parte decision taken in the absence of PIO. The PIO is directed to furnish the remaining information sought at Sl.no. 3,4,6,10 & 12 to the appellant within 2 weeks from the date of issue this order under intimation to this commission. The appellant shall serve a copy of this order to the office of the PIO, obtain acknowledgement and submit a copy of it to this commission. The PIO shall personally attend the next hearing or through his authorised representative.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.

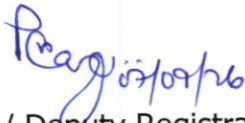
