ORDER

The 3rd hearing held on **23rd April' 2026'** related to the **APIC No-321/A/2025**. The Appellant and the PIO are present through online mode during the hearing before the Commission.

Heard the Appellant;

The Appellant stated that he has not received the information(s) from the PIO till date and regarding the order passed in the last hearing from the court of the State Information Commission (SIC) pertaining to the transferring of Form-A for which the information are not available at the office of the PIO to the competent office which is the Principal Chief Conservator of Forests (PCCF) Department of Environment and Forest Govt. of Arunachal Pradesh, the PIO has not informed him of the same: whether the Form-A has been transferred to the competent authority or not.

Heard the PIO;

The PIO stated that he has recently joined as the Divisional Forest Officer (DFO) Tezu, and after joining he has undergone training as per requirement and order of the concern department, therefore, he is not aware of the order of the court pertaining to the hearing held on 22nd January' 2026.

Regarding rest of the information which are available at the office of the PIO they are ready to be furnished to the Appellant, and request the Appellant to collect the information from the office of the PIO else, if the Appellant is unable to come and collect the information the PIO is willing to send it through Registered Post at the address of the Appellant.

Regarding transferring of the Form-A the PIO submitted that he will do the needful action within coming Monday, if the copy of the order of the last hearing be made available to him.

After hearing both the parties, the Commission hereby orders;1

- i) The Appellant to make available a copy of the order of the Arunachal Pradesh Information Commission (APIC) dated: 22.01.2026 to the PIO to enable the PIO to do the needful as ordered by this Commission.

- ii) The PIO to provide the information(s) available with his office to the Appellant, and for the rest of the information that are not available at his office to transfer the Form-A to the competent authority from where the information can be obtained by the Appellant.
- iii) The PIO to be present in the next date of hearing without fail, failing which necessary action as provided under the RTI, Act, 2005 shall be instituted against him.
- iv) The Appellant to be present in the next date of hearing without fail, failing which this appeal will be heard and determined ex-parte.
- v) Notice for the next date of hearing need not be sent to both the parties as they are present during the hearing.

The Commission hereby orders;

The next date of hearing be fixed on 9th day of July' 2026 at 10:30 AM (Morning).
