ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village Seppa, Po/Ps-Seppa, East kameng District, Arunachal Pradesh, for nonfurnishing of information by the PIO-EE(Planning), O/o the Superintending Engineer, Rupa Circle, PWD, West Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 29/05/2025 regarding Category of work charged (W/C) serving under Rupa Circle.
- 2). The 1st hearing was held on 25th November' 2025. The PIO-EE(Planning), O/o the Superintending Engineer, Rupa Circle, PWD, West Kameng District, Arunachal Pradesh was represented by Shri Tsering Tashi Dikhpa, APIO. The Appellant Shri Ashok Sangbia was present.
- 3). The APIO submitted that some of the information were furnished to the Appellant on request and the remaining information on the direction of the FAA information were kept ready to be furnished, but the Appellant did not turn up to collect.
- 4). The Appellant submitted that the PIO was charging for the information despite exceeding the time period stipulated under the RTI Act.
- 5). The Commission, under section 7(4) of the RTI Act, directed the PIO to furnish remaining information free of coast to the Appellant through postal service under intimation to the Commission within fourteen days.
- 6). The Commission asked the Appellant to intimate his satisfaction or dissatisfaction after receipt of information.

7). The next date of hearing would be decided on the basis of intimation from the Appellant. In case the Appellant fails to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.
