ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Teli Ango, & Mr. Nagbia Kyokam, C/o Gauhati High Court Itanagar Permanent Bench, Yupia Naharlagun, PO/PS Naharlagun, District Papum Pare, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 18/11/2024 regarding PMGSY Road from Ompuli to Tamang Village, Toru Circle under Sagalee ST, Constituency, District Papum Pare (A.P).
- 2). **The 7th hearing was held on 14th July'2026 (Tuesday) at 1100 hrs.** Shri Techhi Totu Tara, the PIO-Cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Papum Pare District, Arunachal Pradesh was absent. The Appellant Teli Gongo was absent and his Co-Appellant Shri Nangbia Kyokam was present.
- 3). Based on the Appellant letter No. Nil. Dated 5th May' 2026 for furnishing of incomplete information, the Commission had directed the Appellant to submit the list of incomplete information to the Commission as also to the PIO before the next hearing.
- 4). But today during the hearing, the Co-Appellant Shri Nangbia Kyokam failed to produce the list of incomplete information sought from the PIO. The Commission directed the Co-Appellant to ask the Co-appellant Shri Teli Ango to produce the detail list of information not provided by the PIO. Based on the information received from the Appellant, the next date of hearing will be fixed.

4). The absence of the PIO, without prior intimation and justifiable reason, was viewed seriously by the Commission.

5). The Commission hereby directs Shri Techhi Totu Tara, the PIO-Cum-EE(RWD), Govt. of A.P., Department of RWD, Sagalee Division, Toru Circle, Arunachal Pradesh to **SHOW CAUSE as to why Penalty should not be imposed on him under section 20 (1) of the RTI Act, 2005**, failing which Arrest Warrant under Section 18 (3) of the RTI Act, 2005 would be initiated to compel his attendance in the Court for the next date of hearing and further disciplinary action under Section 20(2) of the RTI, Act, 2005 would be invoked against him. The PIO was further directed to provide the remaining list of the information to the Appellant before the next hearing.

6). Take notice that in case of default in appearance on the day of hearing mentioned above, the appeal will be heard and determined ex-parte. The case shall be disposed of, if the Appellant is found absent.

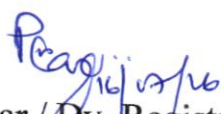
