## <u>ORDER</u>

-7.

The  $3^{rd}$  hearing held on  $3^{rd}$  July, 2025' related to the <u>APIC No-733/2023</u>. The Appellant Shri Tamchi Gungte is absent with a letter of absence citing the reasons that he has got hearing at the office of the Chief Engineer, PHE & WS, West Siang District today, therefore, he has requested the court to postpone the hearing on another date. He also stated that the PIO has not furnished the information(s) to him till date.

The PIO-cum-PD, DRDA, Koloriang, Kurung Kumey District, Govt. of Arunachal Pradesh, found absent for the consecutive three times during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Due to non presence of both the parties the appeal is posted to another date.

Taking serious note of the absence of the PIO for the third consecutive times despite summon being issued to him, **the Commission hereby orders as follows**;

- To issue bailable warrant of arrest to the PIO-cum-Project Director (PD), DRDA, Koloriang, Kurung Kumey District, for securing his attendance in the Fourth Hearing of this appeal.
- ii) To issue notice to the Officer-In-Charge, Koloriang Police Station for executing the bailable warrant of arrest and to return the same on the next date of hearing of this appeal which is fixed on 07.10.5025, 2:30 PM.
- Order for the bailable warrant of arrest be informed to the Deputy Commissioner, Kurung Kumey District and the Superintendent of Police, Kurung Kumey District for compliance of the same.
- iv) The PIO to provide all the information(s) which are available in the office of the PIO on or before the next date of hearing.

The Commission hereby orders;

The next date of hearing be fixed on 7<sup>th</sup> October, 2025' at 2:30 PM (Evening)
